## ASSUMPTION OF RISK, WAIVER OF LIABILITY, INDEMNITY AGREEMENT, SECURITY AGREEMENT AND VIDEO/PHOTO/INTERVIEW RELEASE

For and in consideration of MPC allowing and assisting the Volunteer in the Project, and other good and valuable consideration, receipt and sufficiency of which is hereby Volunteer for himself/herself and his/her personal acknowledged. the representative, assigns, heirs, distributees, guardians, next-of-kin, and any other related people or entities ("Releasors"), hereby irrevocably and unconditionally releases, waives, discharges and covenants not to sue MPC and its affiliates, subsidiaries, divisions, members, directors, officers, employees, agents, third-party project partners, and other volunteers ("Releasees") for and from all claims of any nature now or hereafter existing, whether known or unknown, but not limited to all liability to the Volunteer, death to the Volunteer, or injury to the property of the Volunteer, whether caused by the negligence of the Releasees or otherwise while the Volunteer is participating in the Project, including all travel to or from the Project country. The Volunteer is fully aware of the Risks and other hazards inherent in the Project and voluntarily assumes the Risks and all other risk of loss, damage, or injury that may be sustained by the Volunteer while participating in the Project.

The undersigned further agrees that he/she bears the sole responsibility for

any and all medical expenses which he/she incurs while participating in the Project, whether for injury or illness, or whether as a result of the Volunteer's participation in the Project or not. <u>The Volunteer acknowledges Releasees are under no obligation to, and DO NOT, provide medical insurance for the Volunteer.</u>

### Security Agreement

As a volunteer on a trip or project with MPC or in conjunction with MPC's third-party partners, the Volunteer agrees to abide by any and all instructions, legal or otherwise, given to me by a MPC Project/Team Leader or Representative including, but not limited to, the following:

1. To abide by the instruction of the MPC representatives, team leaders, or other volunteers concerning the taking of visual images or sound recordings or publications that may compromise security or cultural sensitivity.

2. To abide by the instruction of the MPC representatives, team leaders, or other volunteers concerning matters of safety, security, dress, and conduct.

3. To adhere to any instruction regarding the publication and syndication of photographic or digital images, stores, names, etc. obtained because of the Volunteer's participation on this trip.

4. To not publicly implicate any action of MPC for the express purpose of political or religious ambitions.

5. To not make any statement on behalf of MPC without the expressed written permission of MPC.

6. To keep private all photographic, digital, or digital images, stories, names, etc. regarding the Project unless provided with express written permission by MPC.

The Volunteer warrants that he/she has fully read and understands this Agreement and voluntarily signs the same, and that no oral representations, statements, or inducements apart from the foregoing written agreement has been made to the Volunteer.

I acknowledge and agree to be under the authority of MPC, a U.S. non-profit organization. During my time of volunteering with this organization, I understand they will be responsible for overseeing my work in the country to which I am assigned. All personnel

#### Video/Photo/Interview Release

It is understood and agreed that any MPC or its third-party partners' use of my appearance and/or the material supplied by me will not violate any rights of any person or organization(s) and will not incur any liability for payment to any person or organization(s), including copyrights and trademarks. I do further release and hold harmless MPC or its third-party partners against any liability and expenses (including reasonable attorney fees and expenses incurred by any of the above-mentioned parties) with respect to any claim that my words, actions or any material supplied by me violate the right of any person or organization.

In addition, it is understood and agreed that MPC or its third-party partners, may use, or not, any image, likeness, voice, biographical information and/or material supplied by me, including any derivative videotaped programming or photographs in MPC's sole and absolute discretion.
